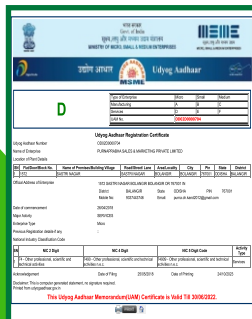
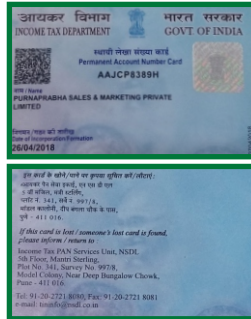

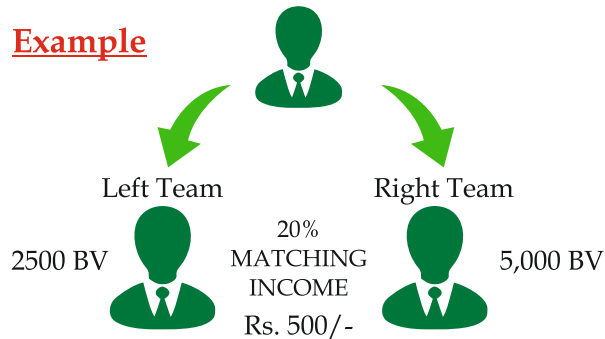

SALES MATCHING INCENTIVE

Business Matching aspect of the Compensation Plan is calculated from your network, with 2 Business Teams - Left Team & Right Team. When an Distributor successfully builds Business Volume (BV) within the network, he / she will be rewarded with the Sales Matching Incentive. Purnaprabha reward its Distributor with Sales Matching Incentive for their efforts in supporting them to get Business volume (BV) based on the order they place. As their team grows, they will be entitled to get Sales Matching Incentive based on the Balanced BV generated oneitherside.

10,000 BV Matching Per 20% = Rs. 2000/-
1,00,000 BV Matching Per 20% = Rs. 20,000/-
11,25,000 BV Matching Per 20% = Rs. 2,25,000/-

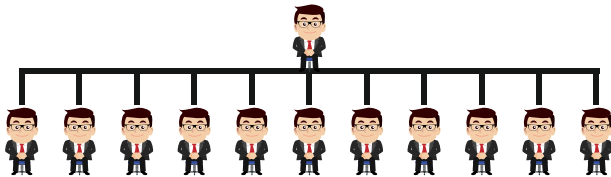

FAMILY HELP ASSISTANCE

1. if an distributor becomes emerald level recognized in purnaprabha, then he can avail the benefits of family security assistance.
- 2.in case of normal or abnormal death at any level after the emerald level, the family will be given financial assistance up to a minimum of 100000/- within 30 days from the purnaprabha company and all the distributor.
- 3.that family will be given financial assistance of minimum rs 10,000 per month from purnaprabha company for 5years.
- 4.along with this, if any major accident happens after getting emerald, then purnaprabha company and purnaprabha distributor will support him for his treatment.

NOMINEE FACILITY

if any distributor has normal or abnormal death then his ID will give his nominee.



TERM & CONDITION

1. The direct seller registration is absolutely free and the company does not ask for any registration fee for it
2. The age of the applicant should be more than 18 years at the time of application.
3. Income in Purnaprabha business plan will be available on the basis of business volume (BV)
4. On selling the products, you will get the facility of buyback within a month.
5. Regarding free ID activation, it is mandatory to activate within 45 days otherwise the ID will be automatically blocked.
6. To credit any payout in your account KYC and PAN card submission is mandatory
7. Sales matching incentive, leadership Bonus incentive payout weekly closing & weekly payout.
8. All type of payout credited in your account at least Minimum Rs. 500/-
9. To avail the benefits of Purnaprabha Business, Pearl rank and above it is mandatory to purchase product worth 2500 BV every month.
10. Company reserves the right to change or amend all the funds from time to time
11. Irrespective of the level attitude, if a distributor found not to have placed any order in preceding three months, then he/she will be termed as an "Inactive distributor" and company reserves the right to take decision (including termination) in respect of his/her Distributorship.
12. The distributor can neither re-pack the products of Purnaprabha company nor change their symbols, marks etc.
13. All distributor should submit passport size photo, ID proof and address proof like driving license, passport, Aadhar card, PAN card and bank passbook copy etc. To the company head office by the last date of the next month of joining for KYC. Deposit is mandatory.

TERM & CONDITION

14. According to government Rules one id per PAN card will be acceptable. Blank ID/gap code will not allowed.
15. TDS will be deducted as per the rules and regulations of the government of india. A service charge 5% will be deducted.
16. If any distributor achieves rank reward achievement, then he will be given rank reward within 90 days.
17. Purnaprabha remuneration program is a hardcore sales & marketing of its products. It is not any type of money-making scheme. It is not an overnight millionaire making program.
18. In case of any confusion and dispute, the decision of the company will be applicable to all distributor and all rights are reserved with the company.

23. The distributors will not make negative or disparaging remarks to the people about the company. They will be always respectful to the company.
24. Company will cancel your distributor ID any time if we found that you are violating our rules & regulations and you are involved in spanning activity.
25. If distributor acting unethical, unprofessional or do not obey the Company's rules & regulations then the company reserves the right to terminate the offending distributor at it's own discretion. In all such cases the company takes decisions in terms of it's bonus, rewards/recongnition policy at it's own discretion.
